

GOLD MEMBERSHIP AGREEMENT

This Gold Membership Agreement (“GMA”) is entered into between aUM Yoga LLC, a Michigan Limited Liability Company (The “Studio” or “Us”) and <CLIENTNAME> (the “Member”, “You” or “Your”) on

<CONTRACTSTARTDATE>:

1. In exchange for the Gold Membership Fee set forth in paragraph 2 and subject to the other Terms and Conditions of paragraph 2, your Gold Membership allows You to take eight (8) classes at Polarity per month. Additional classes can be taken at the reduced drop-in rate of twelve dollars (\$12.00) per class. The Gold Membership Agreement enables clients to take unlimited open pole classes (please see class description) at Polarity during the term of the contract. A month is defined as a thirty (30) day period. The eight (8) classes per month expire after the thirty (30) days and do not roll over into the next month. If you attend all eight (8) classes, you will receive one class at Polarity for free. In order to receive this free class, please email polarityannarbor@gmail.com with a request for this class to be added to your account. The free class must be taken within the eligible 30 day period. This class does not roll over.

2. Please read the following Terms and Conditions of Your Membership CAREFULLY, as they are non-negotiable:

- A. Term: The Initial Term of this GMA is three (3) months, commencing from the purchase date. The Initial Term is non-cancellable, non-refundable, and non-transferable (sans extenuating circumstances). Documentation of extenuating circumstances is required for consideration of any request. At the conclusion of the term of the contract, the contract will expire.
- B. Membership Fees. You must pay all Membership Fees via a valid credit card stored in your MINDBODY Account. Your monthly membership fee is \$120.00/month. Your credit card will be charged in the amount of Your monthly membership fee each month. Membership Fees are non-refundable. There will be a \$50.00 penalty charge for any denied, corrupt, or late payments to be paid with the Membership Fee by the client within forty-eight hours of any offense.
- C. Cancelling A Reservation: If You need to cancel a reservation that you have made, you must do so at least twelve (12) hours before the class time that You reserved. To cancel, please use the EARLY cancel option on MINDBODY so that other people may get into a class instead of being wait-listed. If you cancel after the twelve (12) hour cancellation period has passed, please call 734-707-7419 as soon as possible as a courtesy to the studio. If we are unable to answer, please leave a message. Your failure to cancel within the twelve (12) hour cancellation period will result in a late cancel fee of five dollars (\$5.00) per missed class (that will be charged to your credit card on the date of the late cancel/no show/absence) and you will forfeit the class.

By agreeing to the terms and conditions of this contract you consent and hereby authorize aUM Yoga LLC to charge your credit card for any membership fees and/or penalties outlined herein. You understand that you are required to keep a valid credit card on file. If you remove your credit card from your MINDBODY account, you understand that you are still culpable for any unpaid balance(s) owed to aUM Yoga LLC in addition to any other damages incurred.

Our schedule is subject to change at our discretion. We reserve the right to cancel any class, workshop, or event for reasons including, but not limited to: inclement weather, instructor illness, or low registration. We reserve the right to substitute or change instructors assigned to classes. If class is cancelled due to inclement weather or other extenuating circumstances, class cancellations will be posted on our website, Facebook, and Instagram. Please check our schedule regularly, class times may change, and we may be closed for holiday weekends and/or private events. Contract pricing assumes these closures and contracts will not be extended as a result of them.
